**Regular Meeting** was held at the township hall and called to order at 7:00 pm. with the Pledge of Allegiance recited.

**Present:** Supervisors: Randy Holm, Dave Prieve, John Nowak, Clerk Celia Knoll, Treasurer Laura Holm and three guest.

**Clerks Report:** January minutes were emailed to board for proof reading prior to meeting. Motion made by John N and 2<sup>nd</sup> by Dave P to accept report: Motion carried.

**Treasurer Report:** Report was reviewed. Motion made to approve by Dave P and 2<sup>nd</sup> by John N to accept report. Motion carried.
