Kevin made motion to approve the minutes of the last monthly meeting and it was seconded by Matt. msc.

Kevin made motion to accept the monthly Treasurer’s report along with the bills to be paid, with the exception of the Michael Murphy Construction invoice which we are waiting for documentation, and it was seconded Matt. Msc.

Chairman – David made a motion, and it was seconded by Matt to appoint Kevin Rossow as chairman for 2021. Msc

City of Dassel – Terri Boese and Jim Hallquist attended the meeting to discuss the City’s proposed ordinance of the City annexing land located in Dassel Township. Dassel Township will send the draft ordinance to Bob Ruppe, Township attorney.

Driveways – We received the driveway ordinance template. Kevin will check with Warren Lindberg about width, etc.,

County Ditch 8 – Matt made a motion, and it was seconded by David to replace the culvert on 735th Avenue & County Ditch 8. Msc. We will contact Lindberg Excavating to see if they can do the work.

Cones/Flags – Matt made the motion, and it was seconded by David to purchase ½ dozen cones and ½ dozen reflective flags to be kept by the supervisors for use on the Township roads when necessary. Msc.

Township Assessor – David made the motion, and it was seconded by Kevin to extend Brice Nelson’s, Township Assessors, contract for one more year. Msc.

Emergency meeting – An emergency meeting was called by the supervisors on April 12, 2021 at 9:00 a.m. to inspect 250th, 705th, and 240th along with engineer, Andrew Vistad from Hakanson Anderson.

Chip Seal – Kevin made motion and it was seconded by David to chip seal 1.8 miles / 24 ft wide on 250th and 692. Msc.

Engineer – Kevin made motion and it was seconded by Matt to hire Hakanson and Anderson’s engineer Andrew Vistad to facilitate the project. Msc.

Board of Appeals – The minutes from the April 8, 2021 board of appeals meeting were read and approved by Matt and seconded by David with the correction of the word "by instead to" on the Milo Carlson motion. Msc.

Next meeting – The next monthly meeting will be held on May 10, 2021 at 6:30 p.m. at the Dassel History Center.

David made the motion, and it was seconded by Matt to adjourn the meeting at 8:15 p.m. Msc.
