

The Dassel Township monthly meeting came to order on Monday, May 10, 2021 at 6:30 p.m. at the Dassel History Center.

Present - Chairman Kevin Rossow, Supervisors David Isaacson and Matt Woetzel, Treasurer Galen Nyman, and Clerk Karin Colberg.

Guests – Orville Anderson, Terri Boese, Larry Murphy, Timm Gabrielson and David Raisanen.

David made motion to approve the minutes of the last monthly meeting and it was seconded by Kevin. msc.

David made motion to accept the monthly Treasurer’s report along with the bills to be paid, with the exception of the Michael Murphy Construction April invoice which we are waiting for documentation, and it was seconded Matt. Msc.

Discussion was held on the following –

Timm Gabrielson – He was happy with the cleaning out of the ditch and moving of the bridge on 708th. He would like to widen the field approach on his property which the supervisors said would be alright. He would also like to lower the culvert on his property. He has gotten approval from the DNR. We would like to see that before a decision is made.

Dust Guarding – Orville Anderson had bids from Central MN Dust Guarding for .60/gal and Envirotech for 1.20/gal. David made motion and seconded by Matt to accept the bid from Central MN Dust Guarding. Msc. The property owner will be paying the full amount for the dust guarding this year. It will be \$180.00 for 300 feet. David made motion and seconded by Matt to have the Township dust guard all the intersections on thru roads and 250th and 743rd. Msc.

David Raisanen – He was wondering what the cost of dust guard would be this year.

City of Dassel – Terri Boese wanted to find out if the Township had any questions about the annexation draft. We have 90 days to respond.

Road Maintenance – Larry Murphy had a mapped that showed where all the gravel would go down in the Township. David will talk to Knife River about 705th and Matt will talk to the County about 735th and 745th. Matt made motion and seconded by David to pay Murphy’s March invoice.

Blow outs – Matt said he thought the supervisors should all look over the roads and see what needs patching. Matt will take the 708th and down to Sportsman’s Park, Kevin will check 233rd and 273rd and David will talk to Lindbergs about doing the patching.

RR crossing – Township received a letter from the State about funds that are available for updating the safety on some crossing. One is in Dassel Township. We will discuss at the June meeting. The deadline if June 30, 2021.

Driveways – Matt will check with the County to see if they have specifications for driveways.

County Ditch 8 – David made motion and it seconded by Matt to wait until 2022 to replace the culvert on 735th/County Ditch 8. Msc.

Chip Seal – This will be presented at the June meeting.

Next meeting – The next monthly meeting will be held on June 14, 2021 at 6:30 p.m. at the Dassel History Center.

David made the motion, and it was seconded by Matt to adjourn the meeting at 8: p.m. Msc.
